# 1.0 Introductions

Libben began the meeting by thanking the following for their service to the CLA: Yves Roberge (Past president), Ruth King (Vice-president), Mireille Tremblay (Chair, Program Committee), Julie Auger (Member-at-large) and Fred Mailhot (Student member). Thanks also to Yvan Rose (email list), Daniel Currie Hall (website) and Mikalai Kliashchuk (translation).

A gift was presented to Yves Roberge as a token of our appreciation for his work as president.

# 2.0 Approval of Agenda

Adoption of agenda MOVED (Gold), SECONDED (Heap). Motion PASSED.

# 3.0 Presentations by CFHSS

Ciufo reminded the membership of FedCan's role, that is, to lobby the federal government for funding. Not surprisingly, this has been a difficult year. In the 2009 budget, spending on infrastructure played a big role, but there were also across-the-board cuts to all granting councils. New money for Canada Graduate Scholarships were announced, but all the SSHRC funds are for business and management studies. There was a strong reaction from the community against this move and FedCan is lobbying the government to make all graduate scholarships untargeted. The representatives of FedCan met with the minister of finance and explained that we felt excluded by the budget.

Looking ahead, FedCan has proposed the following five-year budget to the federal government: 100 million in funding for SSHRC, with 50 million for new scholars, 25 million for

more experienced scholars, and 25 million for knowledge transfer (e.g. CURA). In the fall, there will be an economic stimulus update and there are rumours that granting councils will get some good news.

Vandendorpe focused on the issue of Open Access. He noted that there is a class action suit against ProQuest and as a result ProQuest is suing journals. Vandendorpe suggests that this tells us that scholarly journals need to be independent of aggregators. FedCan is trying to determine how it can help journals.

Junker asked about the report on Synérgie and Vandendorpe replied that there is a meeting this Thursday. A system modeled on Érudit will be extended throughout Canada. Ideally FedCan would provide a central server for journals, much like the CNRS in France. They may ask NSERC for server support. Vandendorpe also noted that there is a meeting next week of the Canadian Association of Learned Journals.

Next Congress will be held at Concordia in Montreal. Upcoming meetings will be at UNB/University of St. Thomas, Fredericton (2011), Waterloo/Wilfred Laurier (2012).

# **5.0** President's Remarks (G. Libben)

Libben reported on some initiatives that emerged from his visits to linguistics departments in 2008. It was suggested that the CLA create a database of linguistic expertise, of potential members, and of academic stakeholders. This database would serve as a national resource portal for both linguists and other stakeholders, and would include, among other things, teaching materials and information on research developments. He also reported on the high level of interest in the creation of a program of national recognition awards. The first award will be announced at the next CLA meeting.

Summing up his thoughts at the end of his term as president, Libben mentioned some areas that the CLA could develop: the promotion of multidisciplinarity, the seeking out and engaging of our next association leaders, and the establishment of the CLA as a trusted and sought-out national resource of knowledge, data, and problem-solving expertise.

# 7.1 Report of the Treasurer (C. Dyck)

See attached report. The question of changing the editorial structure was raised again and there will be a vote on proposed changes in the coming year.

7.3 Report of the Editor of the Canadian Journal of Linguistics (S. Cummins) See attached report. Cummins began by noting that the journal is in good intellectual form, with several issues lined up. She has decided to have at most one thematic issue a year and there are no double issues planned, so three single issues will appear each year.

There was some discussion around the causes of the deficit and Cummins noted that there is no one single problem, but that she is planning to bring the journal budget under control. Moreover, the journal has no more outstanding debts.

Cummins announced that Éric Mathieu has agreed to be the Associate Editor and that she has hired Mathieu Tremblay as the editorial assistant. The new editorial board will be announced in the latest issue of the journal. Finally, the website has been updated to be fully bilingual and a new style sheet has been posted.

Acceptance of report MOVED (Junker), SECONDED (LeBlanc). Motion PASSED.

7.8 Report of the Advisor on the Status of Women in Linguistics (E. Gold) This year, Gold organized a lunchtime discussion panel on the topic "Are women happy under Haper?", led by Marymay Downing from the Pauline Jewett Institute of Women's and Gender Studies at Carleton. Gold invited everyone to attend this panel as well as the breakfast discussion on "Language use in museums: First Peoples Hall", led by Stephen Augustine, the Curator of Ethnology (Eastern Maritimes) from the Canadian Museum of Civilization. She also asked for proposals for discussion topics for next year.

# 8.0 Opportunities

Libben opened the discussion by asking how the CLA can better serve the linguistics community and the community at large. Balcom brought up the proposed awards and suggested that they could target both the linguistics community and beyond. Roberge affirmed that we will post a call for nominations this year and that the nomination process will be a simple as possible, so as to encourage participation. Libben will work with Susanne Carroll to have a call within three months.

Luc Baronian brought up the issue of the funding structure within universities, such that science students generate more funding than arts students. Such as system discriminates against

linguistics because some of our work does require equipment. It appears that both Quebec and Ontario have similar systems, with some differences. It was suggested that the Association could lobby the provincial governments to change this system.

David Heap asked whether any lobbying in support of Aboriginal languages took place this year. Pat Shaw replied that two years ago, the Association sent a letter, but we only received an acknowledgement of receipt. No other lobbying has happened since.

# 9.0 Other Business

Carmen LeBlanc noted that some people only attend their own talk and that this is inconsiderate of other attendees. After some discussion, it was decided that there was nothing the Association could reasonably do to address the matter.

The executive thanked Libben for his service as CLA President.

# 10.0 Adjournment

It was MOVED (Gold) and SECONDED (Heap) to adjourn. Motion CARRIED. The meeting adjourned at 6:20 p.m.

# **Summary**

- Most institutional subscriptions are in US
- Canadian subscriptions are about 38% regular members, 46% student members
- Regionally, about 41% in Ontario, 20% in Quebec, 18% in BC, 9% in Alberta
- "Comp" = complimentary copies, "Exch" = exchange, "Abs" = abstracting

# **Comparison with 2008 levels**

- Small increase (2%) overall
- 7% increase in institutional subscriptions perhaps due to journal schedule
- Institutional subscriptions remain below 2007 level, possibly because of e-accessibility
- Project Muse revenue 2007: \$6765.27; 2008: \$19,128.77

# **UTPress Liaison Report**

As some of you probably recall from last year, there were significant problems with membership renewals. In July 2008, Ruth King and I met with Anne Marie Corrigan to discuss this problem and other issues about the journal. The issue with the membership list appears to have been resolved, but Anne Marie took the opportunity to strongly encourage us to change our model of journal editorship. Teams, rather than a single person now run most scholarly journals. It would therefore be beneficial to the journal's profile to adopt a team model (see below for more discussion). Anne Marie also suggested raising subscription rates, and to consider raising institutional rates every year by a fixed amount (e.g. 5%). Based on her suggestions, we raised all rates for 2009: institutional \$75, student \$25, member \$65. And we should discuss regular yearly increases, now that the journal's production schedule has stabilized. However, given the current economic situation, we may choose to keep subscription rates the same for a year, or perhaps make small (2-3%) increases.

In 2006, we held a vote to change the governance model of the CJL, but it was rejected by a vote of 17 in favour and 17 against. I think this result is because of a lack of understanding by the membership of the motivation behind the proposed changes. The CLA executive committee needs to better inform the membership ahead of any future votes on this matter.

Reviewing the rationale behind the changes: continuity of production, relevance and inclusiveness of scholarship, smooth transition of editorial direction. We originally proposed reducing the editor's term to three years (from five) and having the associate editor serve a term of three years and then succeed the editor, for a total commitment of six years. The editor's term is not renewable, but nothing prevents an editor from being named to associate editor. This kind of editorial structure is what Anne Marie Corrigan suggests we adopt.

There were also concerns about confidentiality expressed at the time of the vote. These should be addressed before any future votes.

# Report on the Student Competition (Oral Presentations) 2008 Meeting of the CLA, Vancouver Julie Auger Indiana University Member-at-large

- 1. This year's competition:
- 34 student presentations; no last minute withdrawals
- 3 evaluations per talk
- 16 evaluators
- 5-7 papers/evaluator
- The Program committee provided a list of conference participants who were willing to evaluate papers
- Final recommendation of the committee (excerpted from letter to Prof. Libben)

This year, two student presentations share the Best Student Paper Award. Ms. Heather Bliss's paper entitled "Structuring information in Blackfoot: Against an A'-agreement analysis of cross-clausal agreement" and Ms. Isabelle Charnavel's paper entitled "L'alternance avoir été/être eu dans les auxiliaires du passé surcomposé en français: un nouvel argument pour le caractère syntaxique du morphème se" both received unanimous votes from the committee members. Both students exhibited outstanding presentation and organizational skills and showed great poise during the discussion periods. Furthermore, each presentation provided an excellent illustration of a characteristic very highly valued by the committee: Ms. Bliss presented an original analysis that builds on very solid fieldwork, while Ms. Charnavel presented an insightful and convincing analysis of an aspect of a structure which, to our knowledge, had never attracted any attention on the part of linguists.

Cette année, deux étudiantes partagent le Prix de la meilleure communication étudiante. Mme Heather Bliss, dont la présentation était intitulée "Structuring information in Blackfoot: Against an A'-agreement analysis of cross-clausal agreement" et Mme Isabelle Charnavel, qui a présenté une communication intitulée "L'alternance avoir été/être eu dans les auxiliaires du passé surcomposé en français: un nouvel argument pour le caractère syntaxique du morphème se" ont toutes deux reçu un vote unanime de la part des membres du comité. Dans les deux cas, les présentatrices ont exposé des analyses très bien développées, ont fait preuve d'excellents talents de présentation et ont répondu aux questions qui leur étaient adressées avec confiance et prudence. De plus, les deux communications ont, chacune à leur façon, mis en valeur une qualité très importante aux yeux des membres du comité. Mme Bliss a présenté une analyse théorique originale basée sur un travail de terrain très solide. Pour sa part, Mme Charnavel a décrit un aspect d'une structure qui, à notre connaissance, n'avait été étudié par personne et en a présenté une analyse perspicace et convaincante.

2. One problem arose concerning a student who had indicated in his abstract submission that he was a student and that he wished to take part in the competition for best student paper. For some reason, this information did not reach David Heap, the head of the program committee. As a consequence, I was not aware that he was a student and did not assign any evaluators to his paper. Fortunately, Lisa Travis informed us of this error, and

I was able to get last-minute reviewers to attend his presentation and rate it. It must be hoped that the glitch that caused this error will be fixed in time for next year's meeting.

- 3. This year, I did not have any difficulty finding enough volunteers to have three evaluators per paper. In addition to the conference participants who had indicated that they would be willing to serve on the committee, I targeted all the Vancouver-based linguists I could identify. I established the schedule approximately three weeks before the meeting and shared it with the evaluators, asking them to identify any conflicts that would prevent them from evaluating a paper they had been assigned. Maybe because of this, and in spite of a few last-minute changes in the conference program, no committee member requested any changes to their schedule during the meeting.
- 4. Following the results of the discussion at the executive committee and given the relative ease with which I was able to recruit the colleagues needed to evaluate all the oral student presentations, I propose that we don't discuss or implement any changes in the years to come.

On behalf of the Poster Selection Committee, composed of Parth Bhatt, Judith Gervain, Elaine Gold, Daniel Hall, Diane Massam, Jeff Mielke, Mary O'Brien, Yves Roberge, and myself, I am pleased to report to the Executive of the CLA that the poster event was considered a success: we agreed that the overall quality of the posters was excellent, and we were impressed at the original ways in which the various participants used visual means to convey their research, and at the level of enthusiastic discussion we witnessed at both sessions.

The committee also requests that two other posters, one by H.Bliss & D.R. Storoshenko "Passivization and A'-movement in Shona', and the other by B. MacLeod "The hierarchy of velar weakening in Buenos Aires Spanish", be also recommended for honorable mention.
