ANNUAL GENERAL MEETING

MINUTES

Saturday, May 26, 2012, 4:30 p.m. Arts 1C16, Wilfred Laurier University

1.0 Introductions (F. Martineau)

The CLA executive was introduced: Ruth King (Outgoing President), France Martineau (President), Leslie Saxon (Vice President), Ileana Paul (Secretary), Gerard Van Herk (Program Committee Chair), Jeffrey Steele (Member-at-Large), Sarah Cummins (CJL Editor), Éric Mathieu (CFHSS Representative and CJL Co-Editor). Carrie Dyck (Treasurer) and Paula Caxaj (Student Member) could not attend.

2.0 Approval of Agenda

It was MOVED (Steele) and SECONDED (Gold) to approve the minutes. Motion PASSED.

3.0 Approval of 2011 Minutes

It was MOVED (Poiré) and SECONDED (Steele) to approve the minutes of the 2011 meeting. Motion PASSED.

4.0 President's Remarks (F. Martineau)

Martineau announced certain projects for the coming year. First, the website will be redesigned. Martineau, Steele, Hall and a group of students will collaborate on this project. One of the goals is to increase our visibility. We will hold a contest to create a new logo. Second, we will develop the role of representatives. For example, the representatives will encourage people to attend the CLA annual meeting and to submit to the journal.

Martineau also discussed two related initiatives, the Canadian Language Museum and the Corpus Preservation Committee. She noted that the CLA sent a letter to the federal government to protest the termination of the National Archival Development Program.

Martineau touched on the on-going problem of the low francophone participation at the CLA. It was suggested that we have thematic sessions that would be more appealing to francophone participants. She also mentioned the plan to highlight the host university's strengths at future CLA meetings.

Martineau concluded by thanking Daniel Currie Hall for his work on the website and Yvan Rose for maintaining the listserv.

5.0 Reports

5.1 Treasurer's report (S. Cummins for C. Dyck)

Cowper asked about the SSHRC grant to the Journal – this is found in the Editor's report.

It was MOVED (Gold) and SECONDED (Hall) to approve the Treasurer's report. Motion PASSED.

5.2 Report of the Secretary (I. Paul)

Cowper asked if it is possible to dissociate the membership from subscription. Gold suggested that we need to promote what you get from membership other than journal. The question arose if it is possible to opt out of receiving the paper copy of the journal, perhaps with simply an online subscription. Kucerova noted that many linguists join the Linguistic Society of America to access the website and to submit an abstract to the conference, not to get the journal.

5.3 Report of the Editors of the Canadian Journal of Linguistics (S. Cummins and E. Mathieu)

Hall asked why we are budgeting for a smaller transfer. Cummins explained that we would prefer for the Association to hold any balances we might have.

Clarke wondered what would happen if we didn't print the journal, if there were simply an online version. Cummins noted that production costs would go down, but the SSHRC grant would also go down.

Steele noted that institutional subscriptions might disappear, given that many institutions already have a MUSE subscription.

Again, the question was raised of letting people opt out of getting a paper copy. Cummins agreed to investigate, though suggested it might be too complicated for UTPress to manage.

Cowper asked for an update on the situation with UTPress.

Mathieu reported on the meeting with UTPress that took place in February 2012. Sarah Cummins, Éric Mathieu, and Ileana Paul met with Anne Marie Corrigan to discuss problems the Association has had with the management and promotion offered by UTPress. We are taking a proactive approach to promotion, developing flyers, sending out free copies to conferences, etc. Mathieu also pointed out that the new editorial model is working well.

Kucerova suggested that we highlight a keynote speaker at the annual meeting and invite our deans to attend. Mathieu repeated the suggestion of having thematic sessions and tutorials and workshops.

Catherine Anderson and Dennis Ryan Storoshenko had to renew by phone. It was suggested that we state on the website that if people are having problems subscribing that they contact the Secretary directly.

It was MOVED (Poiré) and SECONDED (Koskinen) to approve the Editors' report. Motion PASSED.

Summary

- Most institutional subscriptions are in US
- Canadian subscriptions are about 53% regular members, 47% student members (this is similar to past years)
- Regionally, about 46% in Ontario, 16% in Quebec, 15% in BC, 7% in Alberta
- Membership remains constant we have yet to return to 2008/2009 levels
- "Comp" = complimentary copies, "Exch" = exchange, "Abs" = abstracting

• It is unclear why numbers have remained low this year – the "Waterloo effect"?

Report on the 2012 Constitutional Ballot [Partie à ne pas traduire]

There were four propositions (given below), but propositions 3 and 4 were housekeeping amendments and members did not vote on these:

Proposition 1. That Article 7 of the Constitution be amended as follows, where revised items are *italicized*

7. COMPOSITION OF THE EXECUTIVE COUNCIL - The Executive Council shall consist of the President, the Vice-President, the Treasurer, the Secretary, the Editor *and Co-Editor* of the journal of the Association, the Chairperson of the Program Committee, two Members-at-large, the Representative to the CFHSS, and a student member.

Rationale: Given the important role of the Co-Editor, the Executive Council proposes to include the Co-Editor as a member of the Executive Council.

Proposition 2. That Article 7 of the Constitution be amended as follows, where deleted terms are struck out.

7. COMPOSITION OF THE EXECUTIVE COUNCIL - The Executive Council shall consist of the President, the Vice-President, the Treasurer, the Secretary, the Editor of the journal of the Association, the Chairperson of the Program Committee, two Members-at-large, the Representative to the CFHSS, and a student member.

Rationale: Given the absence of useful information coming from the CFHSS and a desire to reduce expenditures, the Executive Council proposes to remove the Representative to the CFHSS as a member of the Executive Council.

Proposition 3. That Article 8 of the Constitution be amended as follows, where deleted terms are struck out and revised items are *italicized*.

8. TERMS OF OFFICE OF MEMBERS OF THE EXECUTIVE COUNCIL

b. The Treasurer *and* the Secretary and the Representative to the CFHSS shall be elected to serve for five years, and may serve more than one consecutive term in their respective positions.

Rationale: This is a housekeeping amendment which will be invoked if Proposition 2 passes. It does not need to be voted on.

Proposed Amendment to the By-laws

Proposition 4. That Bylaw 9 be added.

9. TERM OF OFFICE FOR CFHSS REPRESENTATIVE

The representative to the CFHSS shall be appointed by the Executive for a term of five years and may serve a second consecutive term.

Rationale: This is a housekeeping amendment which will be invoked if Proposition 2 passes. It does not need to be voted on.

The vote took place via SurveyMonkey: members in good standing (according to the UTPress data) were sent an email message with a link to the online survey. The ballot was sent out on February 13, 2012, with votes due on March 13, 2012.

52 votes were received from CLA members in good standing.

Proposition 1: accepted 52:0 Proposition 2: ACCEPTED 52:0

The results of the votes were announced over the ACL-CLA list on March 22.

Summary

The journal is on a stable financial footing, and is working with the publisher, University of Toronto Press, to improve operations. There has been renewal on Editorial Board, and a new Squibs Editor, Réjean Canac-Marquis, will come on board soon. Funding from the Social Sciences and Humanities Research Council is assured for three years. To mark the 60th anniversary of the journal in 2015, we plan to have all of our back issues available on MUSE, to honour the proud tradition and the continuing vitality of linguistics in Canada.

Rapport de Éric Mathieu, représentant de l'Association Canadienne de Linguistique auprès de la FedCan

 CFHSS is pleased to note the commitment to research excellence and innovation in this year's federal budget. The Economic Action Plan proposes new investments to promote research partnerships between industry and the academy, including \$7 million per year in funding for the Social Sciences and Humanities Research Council.

Question: Are the investments really that great? It seems to me that there is less and less money for fields such as linguistics. What are the consequences of the new SSHRC reviewing process?

Equity movement: promotion of the full and equal participation of women, visible
minorities, Aboriginal people, LGBTQI2-S persons and persons with disabilities.
As a result of the increased emphasis on the internationalization of students and
faculty in recent years, we now see a greater diversity within the academy in
every campus across the country.

Comment: wishful thinking? Many Canadian universities do not even have policies for LGBTQI2-S hirings.

• In the humanities and social sciences especially, the nature of academic work can entail scholarly and creative contributions as well as interaction with and dissemination to various audiences. Few tenure reviews in universities and grant adjudication committees of research funders formally recognize this type of scholarly contribution, yet faculty are expected to communicate to diverse audiences. How is this work to be evaluated? How should this work be recognized in the peer review process? This is an area of particular challenge to the SSH community.

Comment: see also issues with publishers and reviewing lately.
