1 João Simões is an Assistant Professor at the Institute for Research on Portuguese-speaking Countries at City University of Macau, China. He earned his Ph.D. in Portuguese-speaking Countries Studies from the same university, a Master's degree in Chinese Studies from the University of Aveiro, Portugal, where he studied language policy and planning of the People's Republic of China, and a Bachelor's degree in Electrical and Computer Engineering from the University of Lisbon, Portugal. Prior to his current position, he taught bachelor's degree courses in Portuguese language and culture at Xi'an International Studies University, China. His research interests include lusophony, Portuguese-speaking countries and their interaction with China, and energy geopolitics. He co-edited the book 'Changing the Paradigm of Energy Geopolitics: Security, Resources, and Pathways in Light of Global Challenges' (Peter Lang Publishers, 2023), and he is co-editing 'The Palgrave Handbook of the Geopolitics of Energy Cooperation' (Palgrave Macmillan, forthcoming).

2 Francisco José Leandro (<https://orcid.org/0000-0002-1443-5828>) received a Ph.D. in political science and international relations from the Catholic University of Portugal in 2010. From 2016 to 2017, he took part in a post-doctoral research programme on state monopolies in China — One belt, one road studies. In 2014, 2017 and 2020, he was awarded the Institute of European Studies in Macau (IEEM) Academic Research Grant, which is a major component of the Asia-Europe Comparative Studies Research Project. From 2014 to 2018, he was the Programme Coordinator at the Institute of Social and Legal Studies, Faculty of Humanities at the University of Saint Joseph in Macau, China. From 2018 to 2023 he was the Associate-Dean of the Institute for Research on Portuguese-Speaking Countries at the City University of Macau (China). He is currently Associate Professor with Habilitation in International Relations at Faculty of Social Sciences at University of Macau. His most recent books are: Steps of Greatness: The Geopolitics of OBOR (2018), University of Macau; The Challenges, Development and Promise of Timor-Leste (2019), City University of Macau; The Belt and Road Initiative: An Old Archetype of a New Development Model (2020), Palgrave Macmillan; Geopolitics of Iran (2021), Palgrave Macmillan; The Handbook of Special Economic Zones (2021), IGI Global; Disentangled Visions on Higher Education: Preparing the Generation Next (2023), Peter Lang Publishers; and The Palgrave Handbook of Globalization with Chinese Characteristics (2023), Palgrave Macmillan. Leandro is a member of OBSERVARE (Observatory of Foreign Relations), which was established in 1996 as a centre for studies in International Relations at the Autonomous University of Lisbon, Portugal).
